### **Program**

Objectives and short description of the BIP:

This BIP aims at developing project management competences within the European business environment.

Its general objective is to create an inclusive and fair environment for learning and academic cooperation in order to increase HEI graduates' insertion on the labour market.

The specific objectives are:

OS1. Acquiring the skills to analyse the strategic context of project implementation (feasibility analysis of the project idea) and to develop a project proposal by defining the project's purpose and managerial requirements.





OS2. Developing the skills to manage financial, human and logistic resources as well as risks related to a project, communication within the project and analysis of project quality indicators.

**June 16-20, 2025:** *Online activity* – Practical activity on elaborating and implementing a project proposal with tutorship from external practitioners (20h)
