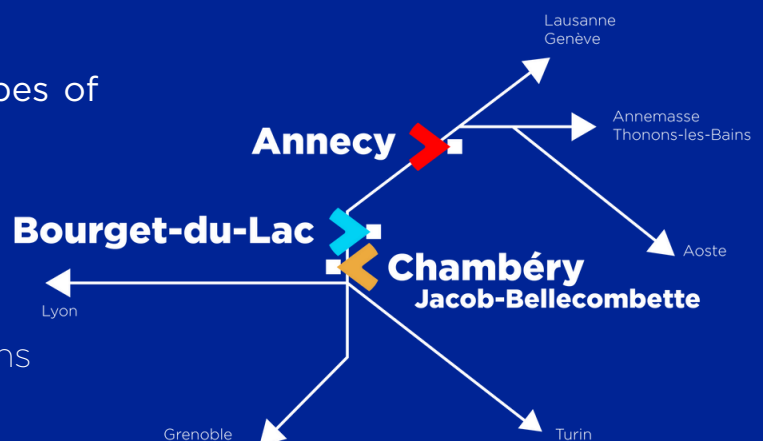

Housing solutions



Welcome to Université Savoie Mont-Blanc

Unlike some other countries, French universities don't own student residences. Students are usually staying in public or private student residences.

What are the differences between public and private student residences?

Public student residences (CROUS)

Public student residences are managed by the national institution CROUS. They are highly demanded.

Important : they only accept students up to 28 years old (except in summer).

How to apply :

- Create your account on : <https://www.messervices.etudiant.gouv.fr/>
- Contact the CROUS, at the following address to get your application form: logement.clous-smb@crous-grenoble.fr

For arrival at the beginning of the school year (September), the application form completed has :



- To be requested from mid-april
- To be sent back before June 16th

You will have an answer mid-July.

Private student residences

Private student residences are managed by private companies. These residences usually offer private studios, really comfortable and more high-end than a public residence, with a lot of services.

How to apply:

Fill the form online on the residence website. You can apply at any moment (see p.5).

You will have an answer within 1 or 2 weeks.

Filling an application form for a public or a private student residence doesn't guarantee you to obtain an accommodation.



VISA: To obtain your proof of accommodation, your housing booking must be confirmed, be careful of the answer delivery time from the residences !

Housing solutions



The 1st month's expenses

- Generally, when you rent a room/flat, the owner will ask you to pay **a guarantee or a deposit (approximately one month's rent)**. You will get it back at the end of your stay if you leave your accommodation as it was when you moved in.
- Whatever the type of accommodation you are going to occupy, **an INSURANCE POLICY for renting a property is mandatory** to insure your accommodation in case of fire, explosion, or water damage... It costs between 30 and 100€ per year. You can purchase a home insurance from a bank or insurance company.
- Before you can rent an accommodation in France, the rental agency or landlord will ask you to provide **a rent guarantor**, a third party who agrees to pay your rent if you cannot. In France, it is customary for a potential tenant to ask a parent to be their rent guarantor. If you do not have any family or close friends in France to fulfill this role, and the agency or landlord requires you to provide a rent guarantor, the French government offers a free alternative solution: the **VISALE** service. (www.visale.fr/#!/visale.locataire).
- Depending on your accommodation, don't forget to add: electricity, water, gas and/or Internet costs...

Accommodation allowances

These state subsidies, or **financial allowances**, make it possible to reduce the monthly rental price (except for the first month).

Attribution depends on the characteristics of your accommodation and on your personal situation.

To get this financial allowance, apply online:

You will need to present the following documents:

- a statement from your landlord attesting your lease,
- full bank account details. This subsidy can only be transferred on a French bank account,
- a certified translation in French of your birth certificate,
- if you are from a country in the European Economic Area : a national identity card OR family record book OR a passport OR residence permit,
- if you come from a country outside the European Economic Area: a currently valid residence permit ("carte de séjour").

It is better to have your administrative documents translated into your country: it will cost you less!
