

# Title of BIP: Religions in Conflict. From the Reformation to the 21st Century

## **General information**

## **Objectives and Description:**

This BIP course aims to improve understanding of the religious conflicts that have plagued Europe from the 16th century to the present day. The course will explore the dynamics of exclusion and repression on religious grounds. Similarly, it will offer new insights into how these conflicts resulted in the reinforcement of an intolerant group identity based on religious orthodoxy. Practical sessions will enable us to analyse the repression of religious dissent through inquisitorial processes and other documents on religious violence.

Only by developing a rigorous understanding of the past can we hope to gain insight into the conflicts that affect our present. The final part of the course will introduce students to the process of adapting religions to a democratic framework and analyse how this conflict-ridden past has been remembered. It will also present the solutions offered by policy-makers and organizations in the present day.

## Methods and outcomes:

The course will feature the participation of various international specialists in the field. Their presentations will take place in two parts: a first part in lecture format, lasting 50 minutes, and a second part open to dialogue with the students, who will be able to raise their own questions and concerns.

Aware of the importance of complementing these sessions with practical cases. Two case studies have been programmed with the participation of professionals from two religious archives in the city of Zaragoza: the Archive of the Archbishopric of Zaragoza and the Archive of the Metropolitan Chapter of Zaragoza.

Finally, a roundtable discussion will be held to encourage debate and reflection. It will be led by policymakers and representatives of organizations seeking to overcome religious differences and prejudices and create a framework of peaceful coexistence among the various denominations
