

Title of BIP: Specialised Training for Agents of Innovation & Entrepreneurship

Objectives and Description:

- Developing knowledge about intellectual property, patents, and innovation policies
- Capacitation to identify and value technological innovations with market potential
- Teaching negotiation techniques, partnerships management and licensing contracts
- Offer tools to develop innovation commercialization strategies

Methods and outcomes:

Format: Hybrid (online classes + final in-presence component)

Workload: 89 hours (3 ECTS) - online-only participation results in 2 ECTS

Teaching methods: Online synchronous/asynchronous lectures, case studies, mentoring, teamwork, and a final project

Expected outcomes:

- Knowledge of technology transfer, innovation ecosystems, and IP strategies
- Skills in market validation, negotiation, and commercialization of innovations
- Practical experience through case studies, mentoring, and final innovation strategy project
